- This dog is, to the best of knowledge, free from communicable diseases and has been vaccinated and wormed regularly. It is recommended that buyer's Vet exam the dog within 48 hours of purchase.
- This dog is being purchased as potentially suitable for the purpose of show and breeding. No guarantee will be made that this dog will finish his championship only that he has no disqualifying features.
- This dog is guaranteed against hip dysplasia and congenital eye defects. If the dog exhibits the above defects, he shall be replaced by a puppy of equal or better quality upon return of dog to breeder, or proof of spay or neuter. NO CASH WILL BE REFUNDED.
- If this dog is used for breeding before he has been x-rayed and rated by OFA and cleared by a CERF certified ophthalmologist (CERF clearance should be done annually) this contract becomes null and void.
- The breeder will remain as co-owner on the dog's papers until CERF and OFA have been obtained, the dog has earned an AKC, Can. or ASCA title and the terms below have been met.
- *If this dog is male:* The breeder/breeders reserves stud rights to this dog, but will be limited to 2 breeding per year. All expenses incurred from maintaining and showing the dog will be the sole responsibility of the buyer.
- *If the dog is female:* The terms below will be agreed to:
  -
- This dog will be fed a high quality food for his lifetime. He will have all proper and regular Veterinary care for his lifetime. The owner has agreed to train this dog in basic obedience and housebreak this dog.
- This dog will be kept in a safe and proper environment at all times. Neither be allowed to roam at large or be kept tethered for any great length of time, a fenced yard being the preferred method of restraint.
- If this dog is found to be abused or neglected or mishandled in anyway, breeder may come onto a premise or enter a building containing this dog and take him back. No money will be refunded.
- If this dog is to leave the ownership of the purchaser, the breeder must be notified and dog will be returned to the breeder. This dog is registered with AKC and ASCA. Papers will be transferred promptly. Owner agrees to register this puppy with both organizations before his first birthday.
- Purchaser agrees not to sell this dog or any of it's offspring to any pet shop, or to anyone intending to breed for commercial resale.
- This dog is to be CERF cleared every 1-2 year up to the age of 8 yrs.( or until he is neutered) Hips and elbows OFA or Penn-hip certified. Results to be reported to breeder.
- All dogs bred to this dog must be OFA and CERF, have an excellent temperament and be of good quality overall.
- Purchaser agrees to report to breeder any health or temperament issues of any kind that involve this dog so that the breeder may use the information for the good of the Hearthside breeding program.
